6. that the results of the institution shall be satisfactory every year.
7. that the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.
8. that the list of Governing Body shall be furnished to the District Educational Officer every year.
9. that the pay structure/fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
10. that all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be complied with.
11. that the school shall not be closed without giving notice both to the parents/District Educational Officer and competent authority at least 6 months before.
12. that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. that the society shall be submit proposals for Renewal of Recognition on or before 6 months prior to the date of expiry of the renewal.
14. that the management of the school maintained fire extinguishers sufficiently in the school premises.

Previously Renewal of Recognition has been accorded to the classes **VI to X (EM)** of **St.Joseph's English Medium High School, Gunadala, Vijayawada, Krishna District** during the years from 2008-2009 to 2017-2018 in Proceedings Rc.No. 4192/B2/2008, Dated.21.09.2007 of the Regional Joint Director of School Education, Kakinada in the reference 5th cited. The **Correspondent** has submitted the application for **Renewal of Recognition** for the classes **VI to X (EM)** in the school for the years from **2018-2019 to 2027-2028**. The District Educational Officer, Machilipatnam, Krishna District has verified the application for **Renewal of Recognition** with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994. Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby accords **Renewal of Recognition** for a period of **10 (Ten)** years i.e., for the academic years from **2018-2019 to 2027-2028** for the classes **VI to X (EM)** subject to fulfillment of the following conditions in **St.Joseph's English Medium High School, Gunadala, Vijayawada, Krishna District** subject to following conditions.

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Renewal of Recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
15. The management informed that no thatched roof accommodation is allowed to run the School.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
20. The school shall have first aid kit and the teachers shall be trained in first aid.
21. The Correspondent of the concerned school is hereby informed to file an affidavit by April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
22. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
23. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
24. That the management has to maintain trained teachers at all time.
25. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
26. **That the Management of the school is informed to renew the occupancy clearance from the Fire Services Department immediately and submit to this office within one month from the receipt of these orders and also instructed to renew the fire NOC & obtain the Structural Soundness Certificate for the Executive Engineer, R&B / Panchayat Raj entire period of recognition from time to time.**

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed.
