After careful examination of the proposals received from the Deputy Inspector of Schools, Urban Range, Vijayawada vide reference 3<sup>rd</sup> cited and also considering his recommendations and as per conditions prescribed in Govt. orders 1<sup>st</sup> read above, the competent authority i.e., the District Educational Officer, Krishna Machilipatnam is hereby accord provisional recognition to Pre-Primary classes from the academic Year 2018-2019 to 2027-2028 to St. Joseph's pre-primary school, Gunadala, Vijayawada without aid subject to the following conditions:

- 1) that the society shall abide by the instructions/rules and regulations made by the Government of authorized Officer from time to time.
- 2) that the Educational Institution shall serve the needs of the locality more particularly.
- 3) that the Instructions shall adopt the curriculum and syllabus prescribed from time to time.
- 4) that the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
- 5) that the qualified staff within the age limits prescribed by the Government for Govt. Employees shall be appointed as per the staff pattern.
- 6) that the results of the institution shall be satisfactory every year.
- 7) that the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.
- 8) that the list of Governing Body shall be furnished to the District Educational Officer every year.
- 9) that the pay structure/fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
- 10) that all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be complied with.
- 11) that the society shall submit proposals for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the provisional recognition.
- 12) The management should obtain the renewal of fire certificate well in advance from the Fire Department.
- 13) Pre-Primary Schools are classified as Nursery, kindergarten, Montessori, and the like. They shall admit children who are in the age group of 3 to 5 years.
- 14) that the Teacher pupil ratio in respect of the Pre-Primary Schools shall not exceed 1:20 and in respect of all other sections the ratio shall not exceed 1:40.
